INTRODUCTION

Charities spend over £1.1 Billion a year applying for funding, of which 63% of applications are unsuccessful. We do not want your application to become one of those statistics, so before completing our online form, we encourage you to read through this guidance outlining the projects we are looking to support.

As a relatively small foundation, we are keen to work closely with local community led organisations to provide a range of support. Through partnership with our parent company, McCarthy Stone, and other supplier partners, we are able to access funds, resources, volunteers, and materials at little or no cost.

The scale of the projects we look to take on is less important than the difference they will make to the community, so when reviewing applications we are looking to see evidence that your application makes a real impact on the lives of local people.

In particular, our primary focus is on projects that combine our three key charitable aims. A strong application will be one that can demonstrate it will improve the health and wellbeing of older people, help young people through intergenerational activity, and contribute to regenerating the local community in which it is based. To help bring this to life we have included a case study of a recent project.

Before you move to making an online expression of interest, please be confident that you can evidence the above. You can do this a range of ways, using case studies, user feedback, annual reports, online or offline media, and any other supporting evidence you have. We know that your time is valuable, so we continue to develop our application process to be as quick and straightforward as possible.

How are we Governed?

We aspire to deliver our mission with the highest standards of governance, compliance, and values possible. The McCarthy Stone Foundation is an independent registered Charitable Incorporated Organisation (CIO) in England and Wales reg no. 1191504. It is governed by a board of volunteer trustees, from McCarthy Stone and ‘independent’ members from outside the organisation. There is an Operating Committee, responsible for delivering on the charitable purposes, and daily operations are led by our full-time Foundation Manager.

BOARD OF TRUSTEES

The Foundation is led by a board of volunteer trustees, who oversee the governance of the charity, determine strategy, ensure compliance, and decide on grant awards and partnerships.

OPERATING COMMITTEE

The Operating Committee support the delivery of the Foundation objectives and is composed of a group of key stakeholders from within McCarthy Stone. They support the Foundation Manager with engagement and activities across the company.

FOUNDATION MANAGER

The Foundation Manager is responsible for daily operations and management of the Foundation and is a full-time staff member whose costs are covered by McCarthy Stone.

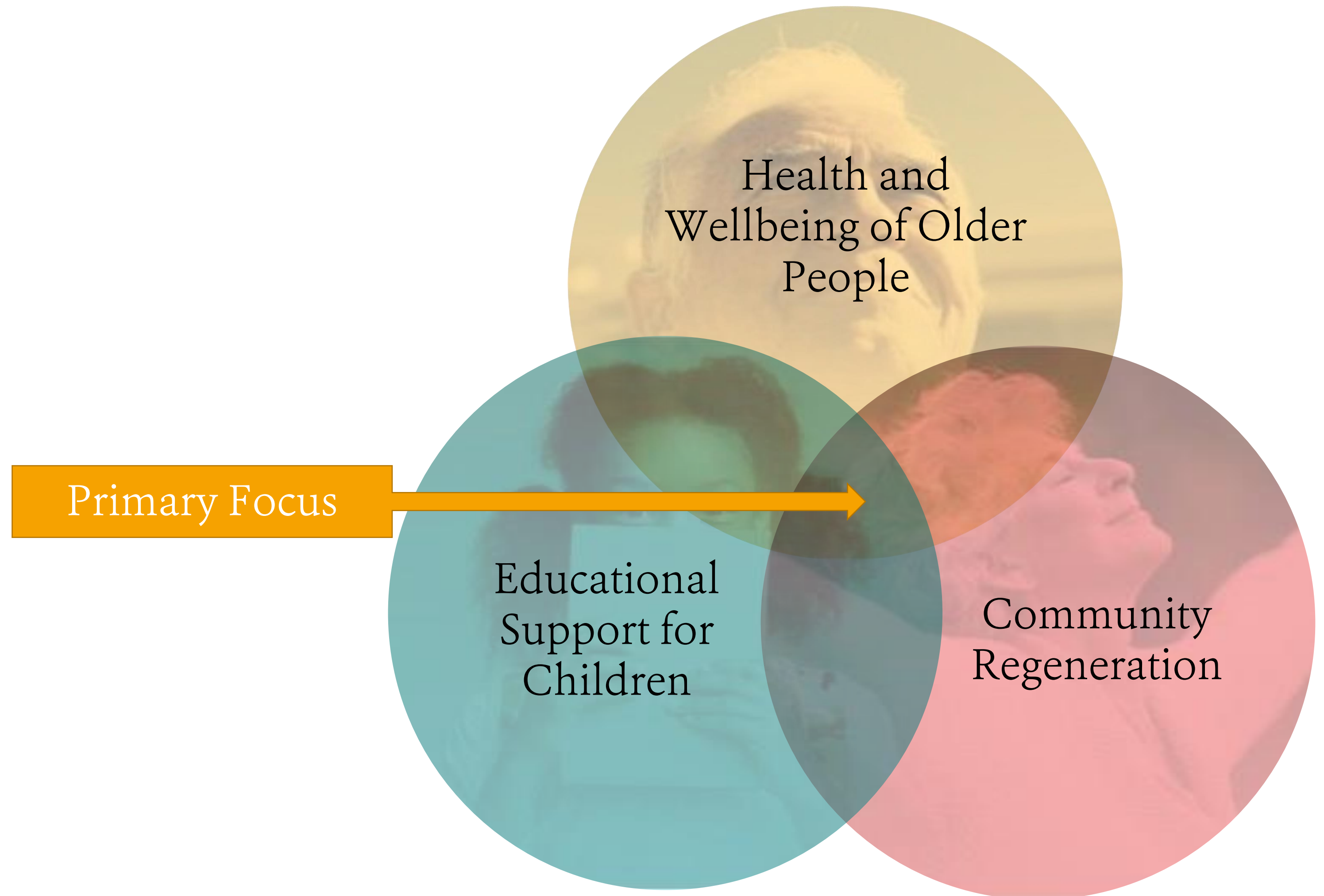

WHAT WE SUPPORT

- Our primary focus is on projects where our three circles of purpose intersect.
- Our secondary focus is on projects where two circles meet.
- We accept applications from Charities, CICs, Community Groups or Social Enterprises.
- Your work must be legally charitable, and we will only award unrestricted funds to registered charities.
- You must have a governing document and a registered bank account for the organisation.
- Grants are generally for amounts up to £5000.

WHAT WE DO NOT SUPPORT

- Contributions to general appeals or circulars.
- Religious activity which is not for wider public benefit.
- Public bodies to carry out their statutory obligations.
- Activities which solely support animal welfare.
- Activities which have already taken place.
- Grant-making by other organisations.
- Privately owned and profit-distributing companies or limited partnerships.



OUR WORK, YOUR IMPACT

The range of ways we can support community projects is diverse.

Aside from direct funding, we are keen to offer additional help where it might be helpful to the success of the project.

Through our network of partners, we are able to bring together volunteers, ranging from construction artisans through to volunteers with a wide range of experience and expertise.

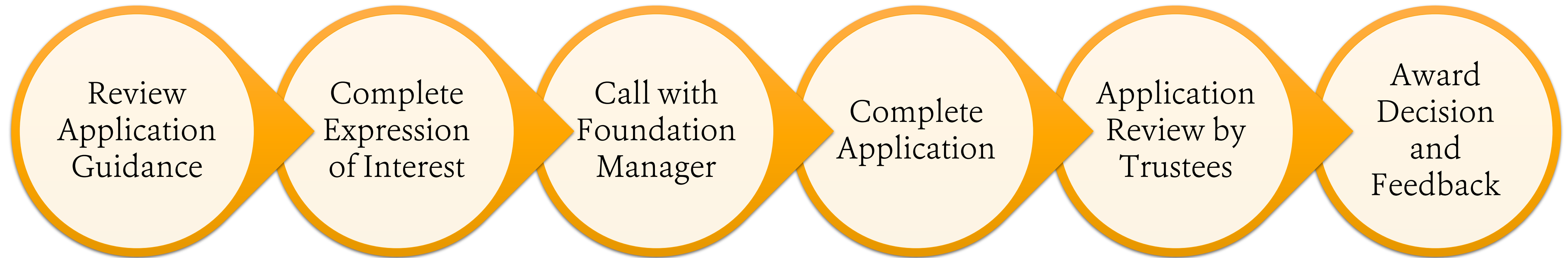




CASE STUDY – ACCESS DORSET – GRANT AND BUILDING WORKS

- Access Dorset initially received a £250 grant from the McCarthy Stone Foundation.
- They work with a diverse range of isolated people, including older adults and young people with learning disabilities.
- Through working together, we identified a project that meets our primary focus for support; to lay a new concrete base for the Access Dorset polytunnel.
- This work will support the charity's 'Build, grow, cook' project, providing activities for the service users, and producing food for the on-site café.
- Working with our supplier partners at Woodmace, who are specialists in groundwork, we will be completing the work for the charity in June 2021. This will result in significant savings for the charity, and enable the project to be completed much faster.
- The work will help regenerate community land, supporting the charity to continue engaging with older adults, often isolated, and younger people with learning difficulties.

COMMUNITY GRANTS – APPLICATION PROCESS



- Trustees review applications quarterly. Cut-off dates for each round of applications will be publicised on the Foundation website and social media pages.
- A copy of our Grant Making Policy will be sent to you with the link to the main application form.
- Please include key details in your Expression of Interest, including:
 - Location
 - Charitable status
 - Funds raised to date (it's perfectly ok if you haven't got any funds raised, but a plan to do so is helpful).
 - Scope of Project
 - How your project meets our Primary Grant Focus
